Dear Chairman Shelby and Ranking Member Shaheen:

Thank you for your commitment to supporting resources for crime victims across our country. As you consider the Commerce, Justice and Science Appropriations bill for Fiscal Year (FY) 2018, we respectfully request that you ensure that outlays from the Crime Victims Fund be as high as possible to fund core programs under the Victims of Crime Act (VOCA) to address the needs of crime victims.

The Crime Victims Fund provides critical resources at the national level to victims in the aftermath of a crime. According to the National Alliance to End Sexual Violence, the Fund helped 4 million victims of all types with support services and reimbursements to restore their lives.

The Fund is comprised of dollars collected from offenders convicted of federal crimes. In an attempt to ensure stable funding for VOCA programs, Congress limited the amount of Fund deposits obligated each year starting in FY 2000. However, the Fund has grown considerably since then and the Fund's balance at the beginning of FY 2017 was \$10.5 billion. Given the great unmet needs of victims of crime at a time when the Fund's balance is considerable, we believe it is both important and fiscally responsible to release additional resources. We commend the Committee for increasing the outlays from the Fund in FY 2015 and FY 2016 to address the growing needs for victim compensation and assistance.


We also urge the Subcommittee to boost outlays from the Fund sufficient to provide for an appropriate funding stream for Tribes. Individuals on tribal lands experience high rates of domestic and sexual violence and resources from the Fund are critical in addressing tribal victims' needs.
