Dear Chairman Blunt and Ranking Member Murray:

As you begin consideration of the Fiscal Year (FY) 2020 Labor, Health and Human Services, Education, and Related Agencies (LHHS) Appropriations bill, we respectfully request that the Subcommittee support substantial new appropriations at the Health Resources and Services Administration (HRSA) to bolster rural emergency medical services (EMS) agencies and fire departments in delivering essential health care for rural America.

Across America's small towns, farming communities, and frontier areas, rural EMS agencies—including those operated by fire departments—are a lifeline to the health care system for residents, who on average are older, have higher rates of chronic illness, and lower incomes. Yet rural EMS faces challenges in delivering quality emergency response and service coordination, in part due to recent declines in primary care and hospital service availability, great distances between health care facilities, and low reimbursement rates. At the same time, EMS agencies face ever-greater responsibilities—preparing for disasters and bioterror threats, supporting the needs of an aging population, and serving on the front lines of the opioid crisis.

These first responders are often the only health care providers in their area and face difficulty in personnel recruitment and retention, and securing expensive equipment. In recognition of these challenges, Congress recently passed the Supporting and Improving Rural EMS Needs (SIREN) Act as part of the 2018 Farm Bill (P.L. 115-334). The SIREN Act reauthorized HRSA's Rural EMS Training and Equipment Program, to directly support public and non-profit rural EMS agencies in their efforts to train and recruit staff, provide education to satisfy certification requirements, and address critical equipment needs—purchasing everything from naloxone and first aid kits to power stretchers or new ambulances.

Robust federal investments to provide substantial grant awards across rural communities in each state will be necessary in FY 2020 to meet the evolving needs of rural EMS agencies and enable them to serve as the back-bone of health care and emergency response in their communities. Thank you for your commitment to this important rural health program.

Justification:	The 2018 Farm Bill (P.L. 115-334) included the SIREN Act, which reauthorized HRSA's Rural EMS Training and Equipment grant program to support rural fire and EMS agencies in purchasing equipment (everything from naloxone and first aid kits to power stretchers or new ambulances) and recruiting, retaining, and training staff members. This HRSA grant program has not received appropriations since FY05. Across rural America, small fire and EMS agencies are often the only health care providers and face challenges in personnel recruitment and retention, and securing expensive equipment—all while serving an older, sicker, and poorer population; confronting geographic barriers and low reimbursement rates; and addressing the opioid crisis.
