- 7 There are hereby appropriated for fiscal year 2026,
- 8 out of any money in the Treasury not otherwise appro-
- 9 priated, for any period during which interim or full-year
- 10 appropriations for fiscal year 2026 are not in effect, such
- 11 sums as are necessary for carrying out without interrup-

- 2 division A of the Full-Year Continuing Appropriations and
- 3 Extensions Act, 2025 (Public Law 119–4), all projects or
