The Madison Staff Assistant is the point of first contact for the Senator and the Madison staff. This position plays a critical role in ensuring that constituents who contact the office know that the Senator is responsive to their concerns.

ESSENTIAL JOB FUNCTIONS:

- o Greets visitors to the Madison office;
- Answers and screens telephone calls for the Senator and other staff members, and takes messages when appropriate;
- O Documents opinions expressed by constituents who call the office in the office's Intranet Quorum database, and prepares the daily "Pulse" report of constituent calls;
- Ensures that requests for assistance are directed to the appropriate staff member in a timely manner;
- o Orders and maintains office supply inventory;
- o Responds to miscellaneous constituent requests for information;
- Performs general data entry and administrative assignments, including providing administrative support for outreach staff around the state;
