Upgrades to the City of Thorp's wastewater treatment plant (WWTP). The plant is more than 35 years old and in need of upgrades due to growth in the community along with not being able to accept more wastewater without biological overloading

and larger flows than the original design.

The WWTP has been meeting effluent limits but has been turning away interested industries due to lack of capacity. The lagoons and the holding pond need to be dredged, they have synthetic liners that are ripped and require replacement, and there is also a need for new aeration equipment. This project will include upgrades to the aeration and lining of the lagoons and pond, a new main WWTP, and a new

main lift station facility.
