

Madison VA PDMP Oversight and Accountability Measures


Below is the William S. Middleton Memorial Veterans Hospital & Clinics Hospital Memorandum No. 119-18-04 "Prescription Drug Monitoring Program Query and Documentation" which describes the facility policy on PDMP queries by prescribers and responsibility for oversight. The facility Pain Point of Contact provides quarterly rates of compliance to facility leadership and primary care management as part of ongoing Opioid Safety Initiative metric monitoring. Updates of these compliances rates are also reviewed by the facility's interdisciplinary Pain Committee at its bi-monthly meetings.

Madison VA Opioid Therapy prescribing reduced by 41% from 2012-2019.


 $Percent \, of \, Unique \, Pharmacy \, Patients \, Dispensed \, Opioids \, Over \, Time \,$


Milwaukee VA PDMP Oversight and Accountability Measures

The Opioid Safety Initiative Coordinator confirmed staff have been educated about the requirements of the PDMP Directive. We have developed local benchmarks for five opiate performance measures to provide feedback on individual providers. Since tracking of the measures began, Milwaukee has shown improvement. Also, we conduct specific chart reviews for patients identified as very high risk of overdose and/or suicide on our Stratification Tool for Opioid Risk Mitigation (STORM) dashboard. Any PDMP deficiencies are noted by our Interdisciplinary Pain Committee as well as our Pain Management Team and addressed with the providers directly.


Milwaukee VA Opioid Therapy prescribing reduced by 44% from 2012- 2019.

Tomah VA PDMP Oversight and Accountability Measures

Local medical center policy (MCM OSI-01 Controlled Substances) addresses expectation for PDMP verification prior to issuance of the prescription order. OSI committee would review PDMP verification as a part of committee reviews of Veterans. Recently, outpatient pharmacists have initiated a process where orders without a PDMP verification are flagged for the provider to complete the verification. Data is reported through OSI to Pain Committee, which then reports to Health Systems Council, which then reports to Senior Executive Council.
