 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Great Lakes Winter
- 5 Commerce Act of 2020".

1 SEC. 2. GREAT LAKES ICEBREAKING OPERATIONS.

2 (a) IN GENERAL.—Subchapter IV of chapter 5 of
3 title 14, United States Code, is amended by adding at the
4 end the following:

5 "§ 564. Great Lakes icebreaking operations

6 "(a) ICEBREAKING OPERATIONS.—The Commandant
7 shall conduct icebreaking operations in the Great Lakes
8 in accordance with the standard for icebreaking operations
9 under subsection (b).

10 "(b) STANDARD FOR ICEBREAKING OPERATIONS.—
11 In carrying out subsection (a)—

12 "(1) except as provided in paragraph (2), the 13 Commandant shall keep channels and harbors in the 14 Great Lakes open to navigation not less than 90 15 percent of the hours that commercial vessels and fer-16 ries attempt to transit ice-covered waterways; and

17 "(2) in a year in which the Great Lakes are not 18 open to navigation because of ice of a thickness that 19 occurs on average only once every 10 years, the 20 Coast Guard shall keep channels and harbors in the 21 Great Lakes open to navigation at least 70 percent 22 of the hours that commercial vessels and ferries at-23 tempt to transit ice-covered waterways.

24 "(c) REPORT TO CONGRESS.—Not later than July 1
25 of each year, the Commandant shall submit to Congress
26 a report on the icebreaking operations conducted by the

Coast Guard in the Great Lakes for the most recent fiscal
 year for which data are available.

3 "(d) COORDINATION WITH INDUSTRY.—The Com4 mandant shall coordinate Great Lakes icebreaking oper5 ations with operators of commercial vessels.

6 "(e) ICEBREAKING IN CANADA.—Except when nec-7 essary to assist commercial vessels documented under title 8 46, United States Code, that are operating in Canadian 9 waters or for the safety of life, the Coast Guard shall 10 prioritize icebreaking in United States waters of the Great 11 Lakes over icebreaking in Canadian waters of the Great 12 Lakes.

"(f) DEFINITIONS.—For the purposes of this section:
"(1) COMMERCIAL VESSEL.—The term 'commercial vessel' means any privately owned cargo vessel of at least 500 tons operating in the Great Lakes
during the winter season.

18 "(2) GREAT LAKES.—The term 'Great Lakes'
19 has the meaning given such term in section 118 of
20 the Federal Water Pollution Control Act (33 U.S.C.
21 1268).

"(3) ICE-COVERED WATERWAY.—The term 'icecovered waterway' means any portion of the Great
Lakes in which commercial vessels operate that is 70
percent or greater covered by ice, but does not in-

1 clude any waters adjacent to piers or docks for 2 which commercial icebreaking services are available. "(4) OPEN TO NAVIGATION.—The term 'open to 3 4 navigation' means navigable to the extent necessary 5 to meet the reasonable demands of commerce, mini-6 mize delays to passenger ferries, extricate vessels 7 and persons from danger, prevent damage due to 8 flooding, and conduct other Coast Guard missions as 9 required. "(5) Reasonable demands of commerce.— 10 11 The term 'reasonable demands of commerce' means 12 the safe movement of commercial vessels transiting 13 ice-covered waterways in the Great Lakes at a speed 14 consistent with the design capability of Coast Guard 15 icebreakers operating in the Great Lakes.". 16 (b) CLERICAL AMENDMENT.—The table of analysis 17 for such chapter is amended by adding at the end the following: 18 "564. Great Lakes icebreaking operations.". 19 (c) REPORT.—Not later than the first July 1 after

20 the first winter in which the Commandant of the Coast
21 Guard is subject to the requirements of section 564 of title
22 14, United States Code, such Commandant shall submit
23 to the Committee on Transportation and Infrastructure
24 of the House and the Committee on Commerce, Science,
25 and Transportation of the Senate, a report on the cost

- 1 to the Coast Guard of meeting the requirements of such
- 2 section.
